

TRI GWP Assessment of Trimoterm Façade Panels MO

Trimo provides transparent and reliable environmental impact data for its products in accordance with EN 15804+A2, the relevant European standard for Type III environmental declarations. Given the wide range and diversity of Trimo's product portfolio, this document presents additional data tables covering the Trimoterm facade panels.

This document focuses on the Global Warming Potential total (GWP_{total}) as the key environmental indicator.

To supplement the published single-product Environmental Product Declarations (EPDs), Trimo applied a validated industry-aligned methodology. All values presented in the following tables are equally robust and suitable for communication with stakeholders seeking clear, standard-compliant environmental information.

The GWP_{total} values for the Trimoterm façade panels portfolio are summarized in the following tables and are expressed in kg CO_2 eq./m². The values for the Trimoterm FTV are also applicable to Trimoterm FTV HL.
